Description of content: MPI is proposing to remove the following pests and any specific measures for these pests in the specific requirements in Part 2 in the Import Health Standard Seeds for Sowing (155.02.05): <ul style="list-style-type: none">• <i>Pseudomonas syringae</i> pv. <i>cannabina</i> and <i>Xanthomonas campestris</i> pv. <i>cannabis</i> from the <i>Cannabis sativa</i> schedule;• Strawberry latent ringspot virus (strains not in New Zealand) from the <i>Fragaria</i> schedule;• <i>Septoria helianthi</i> from the <i>Helianthus</i> schedule;• <i>Coniothyrium lavandulae</i> and <i>Phoma lavandulae</i> from the <i>Lavandula</i> schedule. This change results in the removal of the <i>Lavandula</i> schedule from Part 2 in the import health standard and changes the import requirements for <i>Lavandula</i> seeds to basic requirements;• <i>Penicillium brevicompactum</i> from the <i>Pinus</i> schedule;• Plum pox virus from the <i>Prunus</i> schedule;• Tobacco ringspot virus from the <i>Solanum tuberosum</i> schedule;• <i>Tarsonemus granarius</i> from the <i>Triticum</i> schedule;• High plains virus from the <i>Zea</i> schedule.
